

EXPERIENCE Phylis J. Speedlin arbitrates and mediates hundreds of complex, multi-party disputes. She delivers exceptional value by virtue of her almost four decades of experience as an appellate justice, district court judge, and trial lawyer. Justice Speedlin served as a jurist for 13 years, 10 years as a Justice on the Texas Fourth Court of Appeals and three years as a Bexar County District Court trial judge. During her tenure on the Fourth Court of Appeals, Justice Speedlin authored more than 1,300 opinions, covering a myriad of legal issues, including personal injury, breach of contract, medical negligence, oil and gas, property rights, employment law, construction law, family law, and criminal law.

Since leaving the bench, Justice Phylis has served as the sole arbitrator or member of a panel in over 300 complex cases nationwide. She serves on the American Arbitration Association Commercial, Consumer, Employment, Construction and Appellate rosters. She is also a member of the American Arbitration Association National Healthcare Roster of Arbitrators and has handled dozens of health care arbitrations involving payor provider reimbursement, health care provider contract issues, prompt pay act, statutory compliance issues, breach of contract, and drugs purchased through discount programs.

As a distinguished past litigator herself, Justice Speedlin has mediated over 1,000 commercial, medical, contract, employment, appellate, oil and gas, products, and construction cases.

Originally raised in Ohio, Justice Speedlin obtained a diploma in nursing from Pittsburgh Presbyterian hospital school of nursing in 1970. Soon thereafter she joined the United State Army Nurse Corps where she provided bedside nursing care until 1975 in neurology, oncology, orthopedics, and intensive care.

After leaving the Army Nurse Corp, Justice Speedlin obtained a master's degree in healthcare administration in 1977 and worked as a hospital administrator at the Audie Murphy Veterans Administrative Hospital until 1980 when she entered St. Mary's University School of law where she received her law degree with distinction in 1983.

After law school, Justice Speedlin practiced as a trial litigator for over 17 years and had the distinction of trying over 40 cases to jury verdict mostly in the medical negligence, medical products, and physician credentialing area. Justice Speedlin has been named one of the first woman trial attorneys in personal injury law in the State of Texas. During this time, she also served as corporate council for hospitals located in San Antonio and surrounding counties providing advice on healthcare corporate transactions



and contracting issues, credentialing and peer review, governing documents, and JCAHO accreditation and compliance issues.

Justice Speedlin is board certified by the Texas Board of Legal Specialization in personal injury law. She was appointed to serve on the Texas State Bar Pattern Jury Charge Personal Injury and Oversight Committees for 13 years drafting jury issues used by Texas civil litigators and trial judges. She has also served as a Master on the San Antonio Inns of Court.

A winner of the San Antonio Bar Journal's Outstanding Lawyer Lifetime Achievement Award, Justice Speedlin was also the recipient of the St. Thomas More Award from St. Mary's University School of Law. She has been inducted into the San Antonio Women's Hall of Fame and the Texas Chapter of the National Academy of Distinguished Neutrals.

Phylis served as President of the San Antonio Bar Association, Chair of the San Antonio Bar Foundation Advisory Committee, and Chair of the Community Justice Pro Bono Committee, among dozens of other service and board positions in bar and civic endeavors. Justice Speedlin co-founded and chaired the Community Justice Program, for which she was honored with the American Bar Association's Harrison Tweed Outstanding Pro Bono Award and the State Bar of Texas Judge Merrill Hartman Pro Bono Judge Award.
